DIRECTIONS FOR USE
FēNiX-SRA™ 1LC is a liquid concentrate that must be diluted with water prior to use. Once diluted, FēNiX-SRA 1LC is a water-thin solution that can be sprayed onto hydrophobic soil to aid in restoring the penetrability of the soil. FēNiX-SRA™ 1LC is not intended for use with organic farming. FēNiX-SRA™ 1LC is not to be used as a plant food.

PRODUCT CHARACTERISTICS
FēNiX-SRA™ 1LC concentrate is a viscous, clear liquid product. When diluted in water, FēNiX-SRA™ 1LC becomes a water-thin, clear solution.

The FēNiX-SRA™ 1LC concentrate weighs 9.43 lbs./gal (1.13 g/mL) @68°F.

Avoid Freezing.

USE
FēNiX-SRA™ 1LC is intended for use by forestry management professionals to re-establish moisture retention in naturally occurring and created hydrophobic soils. FēNiX-SRA™ 1LC contains wettings agents which may help to increase the uptake of fertilizer and pesticides. Always exercise caution when using wetting agents with other commonly used turf around valuable plants. Test a limited area prior to large scale applications.

MIXING INSTRUCTIONS
FēNiX-SRA™ 1LC concentrate **MUST** only be diluted with water in a mix tank or a suitable mixing vessel. The recommended dilution rate is 2% mass/mass (2 lb. of FēNiX-SRA™ 1LC concentrate in 98 lb. water) or is recommended that the FēNiX-SRA™ 1LC Concentrate be added to a small amount of the total water. Add the remaining water and mix.

APPLICATION INSTRUCTIONS
Apply the FēNiX-SRA™ 1LC ready-to-sue solution to hydrophobic soil via boom sprayer or back pack sprayer. Minimum and maximum application rates of the diluted read-to use are shown below.
