4. First-aid Measures

Description of first-aid measures.

General advice.

5. Fire-fighting Measures

Extinguishing media.

Methods for Containment.

Avoid dust formation. Take precautionary measures against static discharges. Take up mechanically and collect in suitable container for disposal. Keep in suitable and closed containers for disposal. Use personal protective equipment. Do not dry sweep dust. Wet dust with water before sweeping or use a vacuum to collect dust.

Methods for cleaning up.
